- If you or your parent/stepparent filed a 2008 Federal Tax Return but did not keep a copy, you can obtain a copy from your tax preparer or request a transcript summary and W-2(s) from the Internal Revenue Service @ 1-800-829-1040. You may also log onto their website @ www.irs.gov to download Form 4506T (Request for Transcript of Tax Return). ******* Transcript summaries must be **SIGNED** by the taxpayer. If you filed an amended return, you must submit it along with a copy of the original SIGNED federal tax return.
